Thank you for your interest in the Women's Match Racing at the 2010 Trofeo SAR Princesa Sofia MAPFRE. 38 applications from 17 nations (MNA's) were received prior to the deadline of 14 February 2010. In accordance with the Notice of Race 3.9, the 24 available places are awarded as follows:

The entry allocation process is the same one used at US SAILING's 2010 Rolex Miami OCR (RMOCR) and is as follows: The host MNA receives one entry, and then each MNA receives a single entry. Places are the awarded in the second round to those MNA's that requested more than one entry until the quota is met. 14 alternates are listed to show that 24 plus 14 adds up to 38 applicants. Please find a detailed table below.

The 2009 SWC Standings were used to determine the priority order of which, 14 MNA's participated in the 2009. Those MNA's were ranked in order of their best finisher in the 2009 SWC. Nations that did not participate in the 2009 SWC, were guaranteed a place by applying and were listed and at the bottom of the priority order.

Action Items:

- 1. The following MNA's need to inform us which of their applicants have been selected to fill the awarded places: GBR, USA, AUS and FRA. We request this information by 7 March 2010 so that we may organize the seeding and initial round robins.
